FOREIGN TRADE ZONE (FTZ)

Evans Distribution Systems has operated a Foreign Trade Zone (FTZ) since 1987. Today we operate more than 1 million square feet of General Purpose FTZ #70 out of four facilities.

A foreign trade zone is a secure area in the U.S. or near a port of entry, where products can be designated as legally oustide of U.S. customs territory. Customs duties and excise taxes are due only at the time of transfer from the FTZ for U.S. consumption. If the merchandise never enters the U.S. then no duties or taxes are paid on those items.

Benefits of an FTZ

Many industries such as supply chain, automotive, and general manufacturing use FTZs to gain a competitive advantage. Within these zones, some activities like assembling, manufacturing, and repackaging can be done helping to lower costs for companies. Here are six advantages of operating in an Evans Foerign Trade Zone.

1. Deferral of Duties

Evans' FTZ allows you to defer duties to a later time because your goods have not yet entered the country. It can exempt you from inventory tax and other taxes as well.

2. Relief from Inverted Tariffs

When using our FTZ only the lowest duty needs to be paid. This potentially eliminates the costs associated with importing raw materials because most of the time the tariff on manufactured goods is zero.

3. Elimination of Duties on Waste and Scrap

When importing products to the U.S., an entry fee must be paid. It consists of a 0.21% merchandising process fee with a \$25 minimum and \$485 maximum depending on the value of the goods. These fees must be paid every time product enters the U.S. However, when using Evans' FTZ, custom entries are filed weekly, saving money and time.
